







Implementation of IETP reform in 2025/26 - Summary

- As part of the reform of the initial education and training of pharmacists, the 2025/26 training year will see major changes implemented
- All training posts for England must be recruited through the National Recruitment Scheme (NRS) also known as Oriel
- Training posts must be entered into the system between January and March 2024 for the 2025/26 training year
- All training sites will need to meet the NHS England Workforce Training and Education quality criteria, including using the Assessment Strategy and E-portfolio
- All training sites must confirm that they understand the requirement to provide access to a Designated Prescribing Practitioner (DPP) and a prescribing learning environment
- Details of the DPP and learning environment do not need to be provided in the NRS/Oriel entry, meaning that training sites have a longer period of time to firm up plans for provision of a DPP and prescribing learning setting.

Timeline for recruitment for 2025/26

Date	Activity	Notes
January 2024-March 2024	Training sites entered into Oriel/NRS	 Must agree to terms of participation – agree that will provide access to DPP and prescribing learning environment Do NOT need to identify who the DPP is and where the prescribing environment is IF a multi-sector rotation is being including, must identify where this rotational site is
June 2024-October 2024	Application and Preferencing	Applicants apply to the NRS and create their preferences; a list of sites in which they wish to train
September 2024- October 2024	Assessments	Applicants undertake their recruitment assessment activity
December 2024	Allocation	Employers informed of trainees allocated to their training programmes and begin contacting them
Jul/Aug 2025	Trainee starts	

On the Horizon Jan 24 FTY Placements:

- Not a mandated requirement for cross sector placements
- Single sector still acceptable for 2025/2026
- Development of harmonised funded model to be finalised to help with planning
- Training program standardised for all trainees (WTE)

- Information on Placement requirements standardised contract for rotational placement agreement
- Supervision criteria– Role of DPP and DS

Our vison for the future

Engage and work in partnership with all sector leads and representatives. Informed status and intent - current and potential foundation placement providers at every level

Match training partners across the region to facilitate conversations on the development of joint foundation training (FT) programmes Support the development of joint FT programmes suitable for inclusion on the 2025-26 ORIEL portal. Multisector rotations of ≥ 13 weeks in preference to external rotation of 8 weeks minimum.

Build up to capacity where all programmes are multisector of ≥ 13 weeks beyond 25/26.

Call to action

- Consider what you need to do to prepare for the training site requirements in 2025/26 – what can you do? What support do you need?
- Explore system-level relationships to develop cross-sector collaboration opportunities – consider informal, shorter cross-sector rotations in 2023/24 and 2024/5 training years
- Support existing prescribers to use qualification laying groundwork for supervisor role – support non-prescribers to train
- Consider what support you can give to training sites in other sectors, and what you can gain from the relationship
- Engage with the Assessment Strategy and E-portfolio early familiarity will support adaptability to subsequent changes
