DMS Herefordshire

The IT integration at WVT in Hereford has resulted in a simpler way of sending **DMS** through PharmOutcomes so we expect an increase in numbers in January / February. The attachment will no longer be the whole discharge letter but be confined to the medicine related part – including what was started, stopped etc so hopefully will be less confusing.

We also hope that the delayed referral of Pharmacy First to Community Pharmacy from Emergency Department at WVT will get going in January / February too.

PERT (Creon etc) shortages – where need to access unlicenced to fill a prescription please liaise with the surgery to ensure that you are aligned and avoid sending them to the hospital to obtain medication where possible.





Coming soon: Out patients – they will be using FP10 for some patients and posting prescriptions to pharmacies. A leaflet is being designed for patients which will give timeline for patients for process from WVT posting Rx, sending letters to practices and allowing time for the prescription stock to be obtained and dispensing process before they come to collect it.

HW Palliative Care and Antiviral Pharmacies

Winter Vaccinations – Reminder

Thank you to our pharmacy teams for their hard work in vaccinating patients against flu and covid. Please continue to contact eligible people and promote the vaccine offer to ensure as many people as possible are protected going into the winter period. The last available appointment date on the National Booking Service (NBS) will be Friday 20th December 2024 for both flu and COVID-19 although vaccinations can continue to be provided after this date (outreach activities for COVID-19 vaccination should continue to be delivered to underserved communities until Friday 31st January 2025. Flu vaccinations will be available until Monday 31st March 2025).

Pharmacy premises must exhibit a notice, based on information provided by the Office of the West Midlands, at times when the premises are not open. Where practicable the notice should be legible from outside the pharmacy premises, specifying the addresses of other NHS pharmacies and the days on which and times at which drugs and appliances may be obtained from those addresses.

The LPC has prepared a printable A4 sheet for pharmacies to display which can be downloaded <u>here</u>. This sheet is based on the data we received from the NHS.

Pharmacy contractors are expected to have updated their own NHS UK and DoS profiles. If DoS Profile has not been updated in time, pharmacies will need to request emergency profiling changes by the DoS team by phoning 0300 0200 363.

HW - LFD tests service from pharmacies

In line with national guidance care home providers can access free LFD tests for all residents who are eligible for covid treatment assessment via their Pharmacy. In the past 2 weeks we have seen a significant rise in people presenting with respiratory symptoms and we need to ensure that there is access to LFD tests via local Pharmacies across H&W. Pharmacies are listed on the NHS page: Find a pharmacy that offers free COVID-19 rapid lateral flow tests - NHS. Please check your stocks to ensure you can respond to enquiries for these tests.
